

GENERAL SPECIFICATIONS FOR DRIVE IN SYSTEM

NOTES:

1. THE FOLLOWING WORK RELATED TO THE HA-33 DRIVE-UP FACILITY WILL NOT BE PREFORMED BY THE BANK EQUIPMENT SUPPLIER.
 - A. ALL CONDUITS, CONDUCTORS, PANELS, BOXES AND WIRING DEVICES.
 - B. SOURCE, DISTRIBUTION AND CONNECTION OF POWER TO OPERATE EQUIPMENT.
 - C. INTERIOR AND EXTERIOR LIGHTING AND SIGNS.
 - D. ISLAND MUST BE LEVEL AND SMOOTH AT CUSTOMER UNIT.
 - E. CANOPY, ISLANDS, FOOTINGS, DRIVEWAYS, CURBS, PLANTERS, RETAINING WALLS, WALKWAY, GUARD POSTS, ROAD SURFACES, SPACE HEATERS, AND CONVECTORS.
 - F. AFTER TUBE IS INSTALLED, FINISH ALL OPENING AROUND TUBE INCLUDING GROUTING, PATCHING, WATERPROOFING, PAINTING, SEALING AND ACOUSTICAL TREATMENT AS REQUIRED.
 - G. ALL WORK PREFORMED BY THE GENERAL CONTRACTOR AND THE ELECTRICAL CONTRACTOR THAT PERTAINS DIRECTLY TO THE DRIVE-UP FACILITIES SHALL BE COORDINATED WITH THE BANK EQUIPMENT SUPPLIER.
 - H. THE BANK EQUIPMENT SUPPLIER SHALL NOT BE REQUIRED TO INSTALL THE EQUIPMENT PREMATURELY, AND NOT UNTIL CONSTRUCTION HAS PROGRESSED SUFFICIENTLY TO AFFORD REASONABLE PROTECTION AND FROM OTHER CONSTRUCTION HAZARDS. SUCH TIME SHALL BE DETERMINED BY THE BANK EQUIPMENT SUPPLIER.

2. THE FOLLOWING WORK RELATED TO THE HA-33 DRIVE-UP FACILITY WILL BE BY THE BANK EQUIPMENT SUPPLIER.
 - A. FURNISH AND INSTALL CUSTOMER AND TELLER TERMINALS.
 - B. FURNISH AND INSTALL THE PNEUMATIC TUBES FOR EACH REMOTE SYSTEM AS PER THE TERMS OF THE CONTRACT.
 - C. FURNISH AND INSTALL THE CLOSED CIRCUIT AUDIO SYSTEM FOR EACH REMOTE SYSTEM AS PER THE TERMS OF THE CONTRACT.
 - D. FURNISH AND INSTALL THE DRIVE-UP WINDOW (IF REQUIRED) AS PER THE TERMS OF THE CONTRACT.

3. WHEN THE INSTALLATION WORK IS COMPLETED THE BANK EQUIPMENT SUPPLIER SHALL BE CONSIDERED TO HAVE SATISFACTORILY INSTALLED THE PRODUCT. REGARDLESS OF WHETHER OR NOT THE PRODUCT IS IMMEDIATELY PUT TO USE. THE BANK EQUIPMENT SUPPLIER SHALL NOT BE RESPONSIBLE FOR ANY DAMAGE TO EQUIPMENT CAUSED BY OTHER PARTIES. REPAIR OF DAMAGE CAUSED BY OTHERS SHALL BE DONE BY THE BANK EQUIPMENT SUPPLIER AT THE REQUEST OF THE PURCHASER AND AT HIS EXPENSE.

4. THE PURCHASER SHALL PROVIDE SUFFICIENT PROTECTED AREA FOR THE TEMPORARY ON-SITE STORAGE OF MATERIALS, TOOLS AND EQUIPMENT.

5. THE PURCHASER AGREES THAT HE WILL FURNISH AND MAINTAIN DURING THE INSTALLATION OF THIS PRODUCT AN OPENING INTO THE BUILDING OF SUFFICIENT SIZE FOR THE TAKING OF THE EQUIPMENT INTO THE BUILDING, AMPLE PASSAGE AND RIGHT OF WAY FROM SAID OPENING TO LOCATION WHERE THE PRODUCT IS TO BE INSTALLED.
